Important: read all instructions carefully before completing form.

Type or print the following information and submit the filing with Customer Order Instruction Form and payment.

1. Entity Information Enter the following information:

- The legal name of the organization as it appears on file in state records.
- Your Entity or Nevada Business ID Number (NVID). You can find it online at www.nvsos.gov or on past documents.

2. Registered Agent

You must list a Registered Agent who will receive legal documents for your business. Choose one:

- Commercial Registered Agent: Enter the name only
- Noncommercial Registered Agent: Enter the name and full address
- Office or Position with Entity: Enter the title and address of the person within your business

If you're using a Noncommercial Agent or someone in your business, you can provide an email address for official notices. This is optional. The Registered Agent must sign to accept the appointment. If they cannot sign this form, submit a separate Registered Agent Acceptance form.

3. Revival Date Enter the date you want the revival to begin. This can be a past date.

4. Revival Duration

The revival is perpetual (ongoing) unless a specific date is entered. If your business is a Limited Partnership under NRS 88, you **must** enter a specific end date. .

Statement of fact Your statement of fact depends on the type of entity you are reviving or reinstating. Each section varies. **Check your section carefully before you sign to ensure you meet all the requirements.**

5. Signature Sign and submit the form.

Each entity has specific requirements for who is authorized to sign. This form must be signed by a natural person serving as a:

- Corporation: An officer of the corporation
- Limited-Liability Company: A managers or managing members
- Limited Partnership/Limited-Liability Limited Partnership: A general Partner
- Limited-Liability Partnership: A managing partner
- Business Trust: A trustee
- Or natural person specifically authorized by the entity

Include your payment for this filing. The fee depends on the lateness of the filing and whether it is a reinstatement or revival. There is an additional \$60.00 fee if changing the registered agent within the filing. Please contact our office for assistance with calculating the filing fee at 775-684-5708.

You can file online at www.nvsos.gov. Filing online may reduce processing time and help ensure your submission is not delayed.

If you are not filing online, submit your form and payment by mail or in person, and make your check payable to "Nevada Secretary of State."

 - A court order from a Nevada court, or

 - You now seek to revive or continue its existence under Nevada law.

To complete the revival, the certificate must meet these requirements:

- **Confirmation:** The majority of the voting power consents in writing to this filing.
- **Approval:** The general partners with a majority of voting power approved this form in writing before signing.
- **Signature:** An individual that the general partners designated must sign the document.

Business Trust (BT) – NRS Chapter 88A

- **Signature:** The Chief executive officer (CEO), or someone the CEO authorized to sign, must submit and sign a list.

Corporation Sole – NRS Chapter 84- Reinstatement only
